

CAT 100 Years Centennial (Malaga-Spain Trip)

Terms & Conditions Details

1. QUALIFYING PRODUCTS

- This campaign applies exclusively to the following brand-new CAT machine models: CAT 320GX, CAT 323GX, CAT 330GC, CAT 336, and CAT 350.

2. ELIGIBILITY CRITERIA:

- Purchase one or more of the eligible CAT models listed above during the campaign period.
- Provide full payment or a minimum non-refundable deposit of 10% (where applicable) during the campaign period.
- The offer is valid for both individual customers and business entities located in:
Nigeria, Sierra Leone, Liberia, Tanzania, Kenya, and Uganda.

3. CAMPAIGN PERIOD

- The campaign is valid from 14 July 2025 to 15 September 2025.
- Purchases made outside this period will not be eligible.

4. REWARD DETAILS
